## This Managed Models Menu

The models that are available to you therefore depend on whether you choose a Core option or a Plus option, whether you have a Nominated Financial Adviser and, if you do, who your Nominated Financial Adviser is.

#### **Managed Model Profiles documents**

Important information about each model, including information about its Model Manager, investment objective and timeframe, its investment strategy, income setting, asset allocation ranges and investment universe is set out in the relevant 'Managed Model Profiles' document. There are one or more Managed Model Profiles documents covering the models managed by each Model Manager. The information in each Managed Model Profiles document is taken to be included in this PDS. The Managed Models Profiles documents for models used by your Nominated Financial Adviser are the ones that are relevant to you.

#### **Estimated fees and costs**

We have estimated the 'cash fee', 'international securities fee', 'indirect costs' and 'transaction costs' that will apply for the current financial year in relation to each model. These estimated fees and costs are shown in the tables below as a % p.a. of the value of the total assets held in the model. These fees and costs are estimated based on information available to us as at the date of this Managed Models Menu. These estimates may have regard to the fees and costs incurred in similar models available through other Netwealth products or services for the 12 months to 30 June 2020 where available. Where a suitable previous 12-month history is not available, the estimate of the fees and costs may be based on shorter periods and extrapolated for 12 months or based on the assets held in the model at its commencement or at a point in time. ## **Minimum Investment**

This Managed Models Menu specifies a minimum investment for each model. Investing the minimum investment amount may not be sufficient for you to acquire every asset in the model. When you invest in the Managed Account you should consider the number of assets that may be held in the Managed Models you choose and the possible size of holdings in any one asset. Refer to the Managed Account Guide for more information about the minimum investment.

## **Standard Risk Measure**

This Managed Models Menu specifies the Standard Risk Measure ('SRM') 'risk band' for each model. The SRM is based on industry guidance to allow investors to compare investment options that are expected to deliver a similar number of negative annual returns over any 20-year period. The SRM is not a complete assessment of all forms of investment risk; for instance it does not detail what the size of a negative return could be or the potential for a positive return to be less than you may require to meet your objectives. Furthermore, it does not take into account the impact of administration fees and tax on the likelihood of a negative return. You should always ensure you are comfortable with the risks and potential losses associated with your chosen investment options. The table below sets out the meanings of the 7 risk bands of the SRM.

1	Very low	Less than 0.5
2	Low	0.5 to less than 1
3	Low to medium	1 to less than 2
4	Medium	2 to less than 3
5	Medium to high	3 to less than 4
6	High	4 to less than 6
